EADA Business School and la Escuela FEFlaunch a Master in Financial Management

 A collaboration between both institutions to provide training and certification for financial professionals.

Madrid, 1ST of june 2020. EADA Business School Barcelona and Escuela FEF, which is the training centre for the Instituto Español de Analistas Financieros (IEAF)-Fundación de Estudios Financieros (FEF), are set to launch a joint Master in Finance in October.

EADA Business School, which is based in Barcelona and currently features among the top 30 business schools in the world according to the latest *Financial Times* ranking, has signed an agreement with Escuela FEFA, which is the training arm of IEAF-FEF, to jointly provide financial training in Madrid. Participants will have the opportunity to access professional certificates recognised by the Spanish market regulator. The Master in Financial Management, which will commence on-site from October will include a faculty of professors from both schools.

The Master participants will have the opportunity to train for two professional certificates, both of which are endorsed by the IEAF. The first of these corresponds to the CEFA qualification (Certified European Financial Analyst), which is awarded by EFFAS (European Federation of Financial Analyst Societies) via their representative in Spain, the IEAF. This certificate is recognised by the National Securities Market Commission (CNMV) to meet the requirements of the MiFID II (Markets in Financial Instruments Directive), which is the new European regulation designed to improve the security levels of the markets of financial instruments in the Eurozone.

Participants may also opt for the CEVE (Certificate in Expert in Business Valuations). This qualification is highly regarded in the sector as it accredits its holder to carry out business and asset valuations, including principles and strategies of sustainability, environment and corporate governance.

Once participants have passed the relevant exams, EADA and Escuela FEF will offer complementary training activities which will allow the participants to access and complete both certificates.
